Recommendation(s):

Background

On an annual basis, Clerks and By-law staff provides to Council a proposed calendar of meetings for the calendar year. The recommended dates and times for Council, Committee-in-Council, Budget Committee, Public Hearings Committee, and Board of Health meetings for the end of 2022 is included at the end of this memo.

If the Mayor or Members of Council desire to make changes to the draft calendar of meetings attached to this memo, Clerks and By-law Department staff can be directed to alter the calendar of meetings during the July 12, 2022 Council-in-Committee meeting. At the start of the new term of Council in November 2022, Council will need to approve an appointment schedule of Council-in-Committee Chairs and Vice-Chairs.
