## **Cost of Parking**

Provision of parking within a municipality consists of a number of expenses including but not limited to:

- Parking lot construction and maintenance
- Repairs, snowplowing, cleaning
- Engineering requirements
- Line painting
- Signage
- Communication
- Enforcement

Currently the taxpayers of Norfolk County subsidize all expenses related to parking across the County and within all communities.

### Parking Challenges and Enforcement Issues

- 1. Parking in "no parking" zones
- 2. Parking in excess of posted time limits
- 3. Parking on private property
- 4. Inconsistent usage of parking spaces resulting in decreased parking availability







#### Mitigation Efforts

- 1. Corporate-Wide Parking Study (approved through Staff Report CAO 21-73)
- Pilot Project in Downtown Simcoe extended parking lots time restrictions (Staff report CAO 21-71)
- 3. Proposed Pilot Project in 2022
- Increased parking fines in select lake-front communities
- Paid parking various options to be considered







### **Increased Parking Fines**

Seasonal by-law to authorize increased fines between May to September for the communities of Long Point, Port Dover and Turkey Point.

- No Parking: currently \$75 increased to \$150
- Parking in excess of time limit: currently \$30 increased to \$75

Utilizing three (3) by-law enforcement summer students, there would be dedicated enforcement every weekend in each of the three lake-front communities.







# Paid Parking

Paid parking to be established in certain areas between May to September, 2022 for the communities of Long Point, Port Dover, Simcoe and Turkey Point.

- Enhancements and/or extended parking availability in existing parking lots
- Combination of online and pay-station parking payment options
- Rates of between \$2-4/hour and/or \$15-20/day

**Revenues** would be allocated to a dedicated parking reserve to be used for Council approved parking initiatives including but not limited to:

- Parking improvements and traffic enhancements
- Enhanced/additional signage, line painting and lighting
- Offsetting enforcement costs
- Community contribution

Staff Report CAO 21-85 is seeking:

- Approval for staff to further investigate the pilot project
- To proceed with a 30 day public consultation process

Report to Council to be brought in Q1 2022 to determine if the Pilot Project should move forward.

The Report will include:

- Detailed revenue projections
- Costing options for implementation
- Timelines for execution

Feedback received during the public consultation process will be incorporated into the final report in February.
