Finance Comments	The Approved Capital Budget includes \$610,000 for the Zdriluk Drain Construction. Actuals to date, primarily comprised of engineering, total \$109,000. Funding for these projects is to be provided by the issuance of debentures and external recoveries. Based on the bid of \$358,000 (Rounded, Incl. Net HST) from Neil Montague Construction Limited, there is sufficient funds to accommodate this bid. The Municipal Act and Regulations require that prior to commencement of the capital project, Council is required to approve the issuance of long-term debentures. Further, the Treasurer is required to provide a Certificate of Treasurer, certifying that the issuance of the proposed debt will not exceed the financial obligation limit of the municipality. A Certificate of Treasurer – CT# 24-08 required under regulations in the Municipal Act has been completed.
