



**The Corporation of Norfolk County**

**By-Law 2025-59**

**Being a by-law to Amend the Norfolk County Consolidated Rate of Speed By-law 2024-99, being a by-law to Prescribe A Lower or Higher Rate Of Speed For Motor Vehicles On Certain Highways Under The Jurisdiction Of the Corporation of Norfolk County.**

Whereas the Highway Traffic Act R.S.O. 1990, as amended, Chapter H.8, Section 128(2) provides Council with the authority to pass a by-law to prescribe a lower or higher rate of speed, for motor vehicles driven on a highway or portion of a highway under its jurisdiction; and

Whereas Section 9 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that the municipality has the capacity, rights, powers and privileges of a natural person for the purposes of exercising its authority; and

Whereas the Council of The Corporation of Norfolk County deems it expedient and in the interest of the public to restrict the speed of motor vehicles on certain highways under the jurisdiction of The Corporation of Norfolk County.

Now therefore the Council of The Corporation of Norfolk County hereby enacts as follows:

- 1. That the Norfolk County Consolidated Rate of Speed By-Law 2024-99, be amended by the following deletion to Schedule C as follows:

Schedule C – 60 km/hr. Roads in Norfolk County

- 2. That the Norfolk County Consolidated Rate of Speed By-Law 2024-99, be amended by the following addition to Schedule B as follows:

Schedule B – 50 km/hr. Roads in Norfolk County

RURAL	IRELAND RD	LYNN VALLEY RD	800 METERS NORTH OF ST JOHNS RD E	50
VITTORIA	MILL POND RD	VITTORIA RD	SOUTH TO END	50

3. That the Norfolk County Consolidated Rate of Speed By-Law 2024-99, be amended by the following addition to Schedule C as follows:

Schedule C – 60 km/hr. Roads in Norfolk County

RURAL	IRELAND RD	800 METERS NORTH OF ST JOHNS RD E	ST JOHNS RD E	60
